We would equally like to dedicate **February 21 to February 25** to “petitions”. We desire to bring your petitions before God, corporately. This will take place during **Morning Dew from 5am to 6am** on the assigned dates. While we pray corporately for you, your **identity remains anonymous**.

There are a few things you can do to make this process seamless.

- (1) Email your prayer requests to theoutgiversministries@gmail.com no later than Wednesday February 16, 2022.
- (2) In your email, clearly type out the scriptures you have been using to petition the Father, prior. We will join you in agreement to pray corporately.
- (3) Expect to receive answers from the Father. Therefore, activate your faith before these sessions.
- (4) Remember that whenever a person petitions the Father, the principle of Mark 11:24 applies; that person ought to believe
 - i) First, that he or she **receives them (this happens at the level of the Spiritual)**
 - ii) Secondly, that he or she **has them (this happens at the level of the Physical)**

Please, never expect to receive anything from the Father, physically, if you have not first received from Him spiritually.

(5) Plan to show up at the place of prayer at the assigned times.
